If a repurchase offer is oversubscribed and the Fund determines not to repurchase additional Units beyond the repurchase offer amount, the Fund will repurchase the Units tendered on a pro rata basis, and Unitholders will have to wait until future repurchase offer periods to make one or more additional repurchase requests.
